- 5. Questions for the SBA Officers and/or Dean Galligan
 - a. Thank you to SBA for everything this year- Congratulations to the new team of SBA
 - b. Added New Faculty
 - i. Todd Venie- New Library director from the University of Florida
 - 1. Will be teaching legal research and writing/advanced research

- ii. Lisa Avalos
 - 1. From University of Oregon- Will teach mostly criminal/criminal based classes
- iii. Madeline Wasilczuk
 - 1. Cornell international death penalty clinic- Coming to head the Juvenile Justice Clinic
- iv. Nick Briner
 - 1. UCLA environmental justice program
 - 2. Admin, energy, environmental subjects
- v. Leticia Vincent
 - 1. Hired last year—not in the U.S. yet. Will teach civil law and business classes.
 - 2. Unfortunately, her Visa has held her up.
- c. Proctors
 - i. Will have a roaming monitor in additional to no phones
 - ii. Just having discussed the issue—had no reports of cheating in the Fall.
- d. Parking
 - i. Still no response. Said they were going to do gates. Still haven't done them yet. Will go again.
- e. Stress
 - i. Jennifer Gros- Thursday she will be here with JLAP to talk about stress, depression, fatigue, anxiety etc.
 - ii. Anything you say to her will be confidential under state law.
 - iii. 9am-3:15 in W306- Sent out in email. Can make appointment or just walk up that day.
 - iv. Goal is to bring her in a few times a semester and build from there to have someone regularly in the building

6. Questions

- a. Q "Moving to match Main campuses schedule, how are we going to do that?"
 - i. Trying to match their schedule for a few reasons.
 - 1. Spring break—good idea for student
 - 2. Joint Degree programs—want this program to match with law schedule
 - 3. Housing/Facilities—we start early, and the building is not ready when we get to campus, because main campus starts
 - ii. ABA Number of Requires Weeks/Apprenticeship week
 - 1. Some logistical things that need to be worked out
 - 2. But would like to be as close as we can to the main campus schedule
- b. Q "Problem with financials: want to see budgets, income statements etc. Want to get a budget from the beginning of the school year, and overall through the year so that we can see where the money is going?"
 - i. Want a budget from SBA at beginning of school year
 - ii. And at the end of the year an income statement to see how SBA is meeting goals etc.
- c. Q "Council of student organizations. Not sure what it is or where it exists"?
 - i. Needs to be phased out of constitution.
 - ii. Nick Alegro—wants to keep the council of student organizations in place. Think it's important to have student organization leaders attend the meeting.

- iii. Con: student organization leaders don't attend the meeting in the past.
- iv. Current student organization leader's think this is a good idea
 - 1. Nick Allegro wants it to be if you don't come don't get funding
- d. Q "What would you talk about at this meeting that we can't talk about at SBA and then not get funding?"
 - i. Want more of the beginning of the semester talking about scheduling of events, to work out scheduling conflicts
 - ii. Getting together to try to create a calendar that works for all organizations.
- e. Q "What student organizations are you speaking for?"
 - i. Currently only speaking for 5 organizations now. Think that in order to establish plan of action to improve clubs, need to coordinate with SBA.
- f. Conclusion
 - i. Will reintroduce the council of student organizations—will be reimplemented
- g. Q" Swipe card access to the library to prevent undergrads using the library?"
 - i. Brainstormed swipers to get into the library—this is a future idea/item
 - ii. But will have people patrolling and kicking people out
 - iii. Dean Galligan would like swiping for the library, or for the whole building after a certain hour. Want to eventually establish a welcome center at the entrance to budilg to control who comes in.
- h. Q "Status of Water fountain?"
 - i. Submitted several work orders
 - ii. Waiting on LSU main campus to come fix it—be working on it a few times, but not fixed yet.
- i. Q "Reminder- Not Q- Academic advising in library today, Wednesday, Thursday and Friday. This is high quality advising."
- j. Q "60 min hours moving to 50 min hours- there was discussion on this."
 - i. Committee is still discussing this. It hasn't moved. Still talking about it
 - ii. Issue—number of credit hours required for graduation and if I lose 10 min a hour over a course of 42 classes, turns out to be losing 7 classes
 - iii. First year curriculum—can we accommodate with these if we are using the 50 min hours?
 - iv. Many issues that still need to be worked out if we try to change these things.
- k. Q "Has there been a resolution on the hours requirement under the energy certificate?"
 - i. NO- recommendation to get rid of the service requirement- this has passed
 - ii. The grading requirement has not passed yet. Goes from curriculum committee to the full faculty
 - iii. Further along than the 50-min hour requirement
- 1. Q "Status on reducing the degree hours requirement?"
 - i. Status is still 94. Big undertaking to change. Will take a lot of work from staff and students. Working on lowering it more. Seeing how it will affect recruiting.
 - ii. Law school has a positive attitude towards 94—willing to propose and listen and talk. But issue is that, we need more hours to teach two systems. But also do we really need 94, can we reduce this and still teach the material?
 - iii. Most schools in country are between 89-90
- m. Q "What about allow students to choose common law v. civil law?

- i. Has not been talked about a lot. But you can say you have a choice after your first year. The first year you get exposed to all systems, and legal problems between two perspectives, which is a good thing.
- ii. Maybe can look at whether we have the right mix of courses in the first year.
- iii. Do though have a choice after the first year.
- iv. Academic is looking into this currently.
 - 1. Argument against this—chose to do common law, but end of the 3 years decide to stay and take the bar exam and fail and can't pass because they didn't take the civil law courses.
