      - b. We need to discuss whether we think there should be more parking passes available exacerbates the issue
    - 3. Hannah did the parking passes open up to undergrads and were they avaiable to buy passes in our lot
    - 4. Brenna is there a way to get Law students a floor in the garage?
    - 5. Olivia pretty sure undergrads cant buy the law passes, because we have to register for parking passes with our ideas
      - a. I think law center passes are sold out but maybe there is a voucher to allow them for free
      - b. Also have seen multiple people in the law lot parking without law passes should we get campus police to be issuing tickets
    - 6. Katie should we get a little up and down thing to allow people in and out
    - 7. Dee even now we are over sold to allow everyone to get a pass would make a bigger problem. You cant make everyone happy their isnt enough spots
      - a. We fought for less spots last year to try and alleviate some of the problem
    - 8. Julia there have been a ton of people parking very poorly in the lots as well definitely contributing to the issue because they are taking up more than one spot
    - 9. Drake we should sell enough passes that every law student has one, law students shouldnt have to worry about getting a ticket in the law lot

- a. Also if a student drops out or transfers parking and transport dorsnt reopen those tickets
- Another problem is you cant transfer passes students who have classes in the moring couldnt give your pass to someone in the afternoon

  - a. We need to figure out what the current years policy is

- 12. Drake One issue we'll have to deal with too is that LSU sells the "parking garage" passes (which I think is 4th floor & above) to students for a premium... so, unless we get admin to help us get a solid deal, P&T will fight to get that money and keep the status quo

#### b. 2L Class
